## Dues Programs

**Licensed Member Dues:** Licensed membership is open to anyone holding either a valid license as a Professional Engineer in the U.S. or Canada, or an Engineer-In-Training or Engineering Intern certification issued under the laws of any state, territory, possession or district of the U.S., or its international equivalent. Membership includes National, State and Chapter

**Licensed Associate Member Dues:** Licensed membership is open to anyone holding either a valid license as a Professional Engineer in the U.S. or Canada, or an Engineer-In-Training or Engineering Intern certification issued under the laws of any state, territory, possession or district of the U.S., or its international equivalent. Membership includes State and Chapter ONLY.

**Member Dues:** A person who has graduated with a bachelor's degree or higher from an accredited engineering curriculum may also apply for provisional status as a member for up to two years to achieve the full requirements for member grade.

**Student Dues:** A student enrolled full-time in an ABET-accredited engineering program, or an engineering or pre-engineering program that has an articulated or transfer agreement with ABET or an accredited program; or a student enrolled full-time in a graduate level engineering program (university and graduation date must be completed on your application).

**Affiliate Member Dues:** An individual who has an engineering degree, engineering technician degree, or has knowledge and an interest in the profession of engineering. The purpose of such affiliations shall be to assist in promoting the best interests of the professional engineer and the State Society.

**Enterprise Membership:** Enterprise membership is available to any organization employing NDSPE members and potential members meeting minimum membership guidelines. Dues for all NDSPE member employees of an enterprise company are paid by the organization at one time and at a 10% discount. For more information on this program, contact NDSPE.

**Life and Retired Membership:** Engineers who have been members of NDSPE for many years may qualify for life or retired membership and the accompanying dues reduction. To qualify for retired membership, a member must be retired from full-time employment (working no more than 20 hours/week), be 60 years of age and been a member of NDSPE/NSPE for 10 consecutive years. To qualify for life membership, a member must have been a member of NDSPE/NSPE above the student grade for 40 years OR be retired from full-time employment (working no more than 20 hours/week), be 60 years of age and been a member of NDSPE/NSPE for 40 consecutive years.

## Tax Information

Contributions to the NSPE (national) or NDSPE (state) MATHCOUNTS programs, the North Dakota SPEF scholarship program, the North Dakota FE exam fee sponsorship and the NSPE Educational Foundation are 100% deductible as charitable contributions for federal income tax purposes. Contributions (or gifts), dues and fees to NDSPE and NSPE are not tax deductible as charitable contributions for federal income tax purposes. However, they may be tax deductible as ordinary and necessary business expenses. A portion of state and national society dues is not deductible as ordinary and necessary business expenses to the extent that NDSPE and NSPE engage in lobbying. The non-deductible portion of your NSPE dues is 10%. The non-deductible portion of your NDSPE dues is 3%.

## Important PAC Information

Contributions to NSPE-PAC are used to support pro-engineering federal candidates. Contributions to NSPE-PAC are not tax deductible as charitable contributions. Under federal law, all contributors must be US citizens. Contributions to NSPE-PAC are voluntary and you have a right to refuse to contribute without reprisal. You may contribute any amount to NSPE-PAC as long as it does not exceed \$5,000 per calendar year. Federal law requires us to use our best efforts to collect and report the name, mailing address, occupation and the name of the employer of individuals whose contributions exceed \$200 per calendar year. NSPE-PAC may only accept personal or non-corporate checks. If you prefer, contributions can be made by corporate check to support the NSPE Legislative Education Fund. NSPE-LEF supports the administration of NSPE-PAC.

NSPE-PAC is the bipartisan political action committee of NSPE. NSPE-PAC uses contributions from NSPE members, employees and their families to support congressional candidates who support the engineering profession.

NSPE-PAC allows you to participate in the political process while enhancing the power of your contribution. Pooling our resources magnifies our collective influence in the political process. When you make individual contributions to candidates, candidates may not know why you chose to support them. When the NSPE-PAC makes a contribution, however, it sends a strong, collective message from NSPE. There is strength in numbers. You can become a voting member of NSPE-PAC with a \$25 contribution. As a voting member, you will have the opportunity to participate in PAC Board of Trustees elections, recommend candidates for contributions and help choose the issues NSPE-PAC will support.
